

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING CHAPTER 9, SECTION 150 OF THE CODE OF THE CITY OF MESQUITE BY PROVIDING CERTAIN AMENDMENTS THEREBY ESTABLISHING THE SPEED LIMITS IN THE FALCON'S LAIR PHASE 4A SUBDIVISION; PROVIDING A REPEALER CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EMERGENCY.

WHEREAS, the results of an engineering study indicated a reduction from the normal speed limits for the "interior" residential streets to 20 miles per hour in the new Falcon's Lair Phase 4A Subdivision.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Chapter 9, Section 150 of the Code of the City of Mesquite, Texas, is hereby amended to read as follows, in all other respects said Code, Chapter and Section to remain in full force and effect.

Becard Drive	From Clay-Mathis Road to Turn Stone Drive	20
Gannet Drive	From Clay-Mathis Road to Red Start Drive	20
Wood Pigeon Drive	From Clay-Mathis Road to Red Start Drive	20
Red Start Drive	From Clay-Mathis Road to Gannett Drive	20
Turn Stone Drive	From Becard Drive to Gannett Drive	20
Finch Drive	From Turn Stone Drive to Kiwi Lane	20
Kiwi Lane	From Turn Stone Drive to Finch Drive	20
Spoonbill Court	From Turn Stone Drive to its end (a cul-de-sac)	20

SECTION 2. That all ordinances or portions thereof in conflict with the provisions of this ordinance, to the extent of such conflict, are hereby repealed. To the extent that such ordinances or portions thereof are not in conflict herewith, the same shall remain in full force and effect.

SECTION 3. That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional, the validity of the remaining provisions of this ordinance shall not be affected and shall remain in full force and effect.

SECTION 4. That any person, firm or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred (\$200.00) Dollars for each offense.


SECTION 5. That the present ordinances of the City of Mesquite are in need of revision to establish the speed limits in the Falcon's Lair Phase 4A Subdivision as indicated by the results of an engineering study, creates an urgency and an emergency for the preservation of the public health, safety and welfare, and requires that this ordinance shall take effect immediately from and after its passage and publication of said ordinance, as the law in such cases provides.
