AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING CHAPTER 9, SECTION 150 OF THE CODE OF THE CITY OF MESQUITE BY PROVIDING CERTAIN AMENDMENTS TO REFLECT THE NAME CHANGE ON CARTWRIGHT ROAD AND UPDATING THE SPEED LIMITS ON CERTAIN SECTIONS OF CARTWRIGHT ROAD; PROVIDING A REPEALER CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EFFECTIVE DATE THEREOF.

WHEREAS, the City of Mesquite previously changed the name of Cartwright Road and portions of Bruton Road to East Cartwright Road and changed the name of portions of Bruton Road to West Cartwright Road; and

WHEREAS, the extent of speed limits on certain sections of East and West Cartwright Roads needs to be updated to reflect the change in name and recent improvements in roadway geometry; and

WHEREAS, the engineer of record designed portions of Cartwright Road now known as East Cartwright Road from Faithon P. Lucas, Sr., Boulevard to Lawson Road for speeds of up to 50 miles per hour.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Chapter 9, Section 150 of the Code of the City of Mesquite, Texas, is hereby amended as follows, in all other respects said Code, Chapter and Section to remain in full force and effect.

SECTION 2. That all ordinances or portions thereof in conflict with the provisions of this ordinance, to the extent of such conflict, are hereby repealed. To the extent that such ordinances or portions thereof are not in conflict herewith, the same shall remain in full force and effect.

SECTION 3. That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional, the validity of the remaining provisions of this ordinance shall not be affected and shall remain in full force and effect.

SECTION 4. That any person, firm or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred (\$200.00) Dollars for each offense.

SECTION 5. That this ordinance shall take effect on and after June 1, 2004.
