ORDINANCE NO. 3726

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, ESTABLISHING FEES ASSOCIATED WITH THE MESQUITE HISTORICAL MUSEUMS SYSTEM; PROVIDING A REPEALER CLAUSE; PROVIDING A SEVERABILITY CLAUSE; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

<u>SECTION 1.</u> That the various fees associated with the Mesquite Historical Museums System are hereby established and are more fully described in Exhibits "A" and "B" attached hereto.

<u>SECTION 2</u>. That all ordinances or portions thereof in conflict with the provisions of this ordinance, to the extent of such conflict, are hereby repealed. To the extent that such ordinances or portions thereof are not in conflict herewith, the same shall remain in full force and effect.

SECTION 3. That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional, the validity of the remaining provisions of this ordinance shall not be affected and shall remain in full force and effect.

<u>SECTION 4</u>. That the present ordinances of the City of Mesquite are inadequate to provide for the various fees associated with the Mesquite Historical Museums System creates an urgency and an emergency for the preservation of the public health, safety, and welfare and requires that this ordinance shall take effect immediately from and after its passage.

Opal Lawrence Historical Park

Hours of operation – Tuesday through Friday, 10 a.m. to 4 p.m. Saturday, 10 a.m. to 1 p.m. as of official opening

Fees** - S.D. Lawrence House - \$3.50; \$2.50 for seniors 60+; \$2 for children ages 3 to 12

For completed park at 30 hours per week operation (will add hours on Sunday once all buildings are completed) - \$6 for adults; \$5 for seniors 60+; \$4 for children ages 3 to 12

Fees** - \$3 for adults; \$2.50 for seniors 60+; \$2 for children ages 3-12;

Special times – Florence Ranch Homestead Open House, every second Saturday of the month, 10 a.m. to 1 p.m., \$1 flat fee

Group fees - \$2 for adults; \$1 for students

**Members are admitted free with valid membership card.
