

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, REVISING THE CURRENT SCHEDULE OF CHARGES FOR VARIOUS PARKS AND RECREATION SERVICES TO BE EFFECTIVE ON AND AFTER OCTOBER 1, 2005; REPEALING ORDINANCE NO. 3679; PROVIDING FOR A SEVERABILITY CLAUSE; AND DECLARING AN EFFECTIVE DATE THEREOF.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. The current schedule of charges for various parks and recreation services is hereby revised to read as follows:

SECTION 2. That Ordinance No. 3679, which established Schedule of Charges for Parks and Recreation Services, is hereby repealed in its entirety.

SECTION 3. That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional, the validity of the remaining provisions of this ordinance shall not be affected and shall remain in full force and effect.




