

ORDINANCE NO. 3833

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING CHAPTER 5 OF THE CODE OF THE CITY OF MESQUITE BY PROVIDING CERTAIN ADDITIONS AND DELETIONS TO SECTIONS 5-187 AND 5-468 THEREBY AMENDING THE INTERNATIONAL PLUMBING AND RESIDENTIAL CODES, 2003 EDITIONS; PROVIDING FOR A REPEALER CLAUSE; PROVIDING FOR A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY NOT TO EXCEED TWO THOUSAND (\$2,000.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1: That Chapter 5 of the Code of the City of Mesquite, Texas, is hereby amended by providing certain additions and deletions to Sections 5-187 and 5-468, in all other respects said Code and Chapter to remain in full force and effect:

- A. *Section 5-187.* Amendments to the International Plumbing Code, 2003 Edition.
1. *Section 5-187(6)(b).* Amend by deleting the section in its entirety and adding a new Section 5-187(6)(b) to read as follows:
 - (6) *Chapter 6, Water Supply and Distribution.*
 - (b) *Table 605.4.* Amend by deleting the following materials from Table 605.4:
 1. Chlorinated polyvinyl chloride (CPVC) plastic pipe and tubing; and
 2. Polybutylene (PB) plastic pipe and tubing.
 2. *Section 5-187(6)(c).* Amend by deleting the section in its entirety and renumbering current Sections 5-187(6)(d) – 5-187(6)(h) to Section 5-187(6)(c) - 5-187(6)(g).
- B. *Section 5-468.* Amendments to the International Residential Code, 2003 Edition.
1. *Section 5-468(17)(d).* Amend by deleting the section in its entirety and adding a new Section 5-468(17)(d) to read as follows:
 - (17) *Chapter 29, Water Supply and Distribution.*
 - (d) *Table P2904.* Amend by deleting all references to the following materials in Table P2904.5:

- Polybutylene (PB) plastic pipe and tubing;
- Chlorinated polyvinyl chloride (CPVC) plastic and tubing.

2. *Section 5-468(17)(e).* Amend by deleting the section in its entirety and adding a new Section 5-468(17)(e) to read as follows:

(17) *Chapter 29, Water Supply and Distribution.*

(e) *Sections P2904.5.1 and P2904.14.* Amend by deleting all references to the following materials in Sections P2904.5.1 and P2904.14:

- Polybutylene (PB) plastic pipe and tubing;
- Chlorinated polyvinyl chloride (CPVC) plastic and tubing.

SECTION 2. That all ordinances or portions thereof in conflict with the provisions of this ordinance, to the extent of such conflict, are hereby repealed. To the extent that such ordinances or portions thereof are not in conflict herewith, the same shall remain in full force and effect.

SECTION 3. That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional, the validity of the remaining provisions of this ordinance shall not be affected and shall remain in full force and effect.

SECTION 4. That any person, firm or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Thousand (\$2,000.00) Dollars for each offense.


SECTION 5. That this ordinance shall take effect immediately from and after its passage.
