AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, HOLLEY STREET **RIGHT-OF-WAY** THE ABANDONING BETWEEN BRYAN-BELT LINE ROAD AND CARVER STREET; PROVIDING FOR A REPEALER CLAUSE; PROVIDING FOR A SEVERABILITY CLAUSE; AND DECLARING AN EMERGENCY.

WHEREAS, White Properties, Inc., has requested the abandonment of the segment of Holley Street right-of-way (ROW) between Bryan-Belt Line Road and Carver Street; and

WHEREAS, White Properties, Inc., owns all the adjoining land to the north and south of this segment of Holley Street; and

WHEREAS, the ROW is no longer needed for public purposes and it is in the public interest of the City to abandon said described ROW.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

That the segment of Holley Street right-of-way between Bryan-SECTION 1. Belt Line Road and Carver Street, more fully described in Exhibit "A" attached hereto and included herein for all purposes, shall be and the same is hereby abandoned.

That all ordinances or portions thereof in conflict with the SECTION 2. provisions of this ordinance, to the extent of such conflict, are hereby repealed. To the extent that such ordinances or portions thereof are not in conflict herewith, the same shall remain in full force and effect.

That should any word, sentence, clause, paragraph or provision of SECTION 3. this ordinance be held to be invalid or unconstitutional, the validity of the remaining provisions of this ordinance shall not be affected and shall remain in full force and effect.

That the orderly development of the City of Mesquite requires the SECTION 5. release and abandonment of the right-of-way described herein, creates an urgency and an emergency for the preservation of the public health, safety, and welfare, and requires that this ordinance shall take effect immediately from and after its passage and publication of said ordinance as the law in such cases provides.
