CITY OF MESQUITE

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS OF THE ABANDONMENT OF A PORTION OF A 15-PROVIDING FOR THE ABANDONMENT OF A PORTION OF A 15-PROVIDING FOR THE PEPSICO BOTTLING FACILITY LOCATED AT IH-30 AND BIG TOWN BOULEVARD; PROVIDING FOR A REPEALER CLAUSE; PROVIDING FOR A SEVERABILITY CLAUSE; AND DECLARING AN EMERGENCY.

WHEREAS, research of the area indicated the sanitary sewer easement was dedicated on August 3, 1964, for the exclusive use of constructing and maintaining a sanitary sewer main; and

WHEREAS, Staff received a request for the abandonment of a portion of the 15-foot-wide sanitary sewer easement; and

WHEREAS, Staff believes the abandonment is in the public interest and recommends abandonment of the subject sanitary sewer easement.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That a portion of the 15-foot-wide sanitary sewer easement associated with the expansion of the PepsiCo Bottling facility located at IH-30 and Big Town Boulevard, more fully described in Exhibit "A" attached hereto and included herein for all purposes, shall be and the same is hereby abandoned.

SECTION 2. That all ordinances or portions thereof in conflict with the provisions of this ordinance, to the extent of such conflict, are hereby repealed. To the extent that such ordinances or portions thereof are not in conflict herewith, the same shall remain in full force and effect.

SECTION 3. That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional, the validity of the remaining provisions of this ordinance shall not be affected and shall remain in full force and effect.

SECTION 4. That the orderly development of the City of Mesquite requires the release and abandonment of a portion of the sanitary sewer easement described herein, creates an urgency and an emergency for the preservation of the public health, safety and welfare, and requires that this ordinance shall take effect immediately from and after its passage and publication of said ordinance as the law in such cases provides.

## EXHIBIT A 15' UTILITY EASEMENT ABANDONMENT

BEING a 14,299 square foot tract of land situated in the W. O. COMMENCING at a 5/8-inch found iron rod for the common northerly northeast corner of Pepsico Addition, an addition to the City of Mesquite as recorded in Volume 97150, Page 5607 of the Plat Records of Dallas County, Texas (P.R.D.C.T.), and most westerly corner of Action Commercial Addition, an addition to the City of Mesquite as recorded in County Clerk's Document # 200503542044, O.P.R.D.C.T., said point being on the southeasterly right-of-way line of Interstate Highway 30, a variable width right-of-way;

THENCE South 29 degrees 56 minutes 55 seconds East, departing said southeasterly right-of-way line and along the common line between said Pepsico Addition and said Action Commercial Addition, a distance of 181.77 feet to a point for the northwest corner of said Bottling Group, L.L.C. tract;

THENCE North 88 degrees 57 minutes 46 seconds East, departing said common line and along the common southerly line of said Action Commercial Addition and northerly line of said Bottling Group, L.L.C. tract, a distance of 73.96 feet to a point for corner;

THENCE South 48 degrees 12 minutes 04 seconds East, continuing along said common line, a distance of 479.83 feet to a point for corner;

THENCE South 11 degrees 13 minutes 49 seconds East, continuing along said common line, a distance of 100.00 feet to a point for corner;

THENCE South 56 degrees 08 minutes 11 seconds East, continuing along said common line, a distance of 149.90 feet to a set "X" cut for the POINT OF BEGINNING, said point being on a westerly line of said 15 foot wide utility easement;

THENCE South 56 degrees 08 minutes 11 seconds East, continuing along said common line, a distance of 18.26 feet to a point for the common northeast corner of said Bottling Group, L.L.C. tract and northwest corner of Block A, Lot 1 of East Meadow Apartments, an addition to the City of Mesquite as recorded in Volume 84077, Page 3910, D.R.D.C.T., and from which point a 1/2-inch found iron rod bears South 26 degrees 08 minutes 22 seconds East a distance of 1.27 feet;

THENCE South 00 degrees 53 minutes 28 seconds East, departing said common line and along the common line between said Block A, Lot 1 and said Bottling Group, L.L.C.

tract, a distance of 385.42 feet to a 1/2-inch set iron rod with a yellow plastic cap stamped "HALFF ASSOC INC" (hereinafter referred to as "with cap") for corner;

THENCE South 88 degrees 49 minutes 05 seconds West, departing said common line, a distance of 15.00 feet to a 1/2-inch set iron rod with cap for corner on a westerly line of said 15 foot wide utility easement;

THENCE North 00 degrees 53 minutes 28 seconds West, along said westerly easement line, a distance of 113.37 feet to a point for corner;




