## ORDINANCE NO. 4004

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING CHAPTER 9, SECTION 9-150 OF THE CODE OF THE CITY OF MESQUITE BY REVISING THE EXTENT OF THE SPEED LIMIT ON BIG TOWN BOULEVARD FROM NORTH CITY LIMITS TO SAMUELL BOULEVARD; PROVIDING A REPEALER CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENSE; AND PROVIDING AN EFFECTIVE DATE THEREOF.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Chapter 9, Section 9-150 of the Code of the City of Mesquite, Texas, is hereby amended as follows, in all other respects said Code, Chapter and Section to remain in full force and effect.

## Sec. 9-150. Same – Designated for certain streets.

A. Amend by deleting the following:

Big Town Boulevard From north city limits to Samuell Boulevard

B. Amend by adding the following:

Street Extent Speed (mph)

Big Town Boulevard From north city limits to Samuell Boulevard 40

SECTION 2. That all ordinances or portions thereof in conflict with the provisions of this ordinance, to the extent of such conflict, are hereby repealed. To the extent that such ordinances or portions thereof are not in conflict herewith, the same shall remain in full force and effect.

SECTION 3. That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional, the validity of the remaining provisions of this ordinance shall not be affected and shall remain in full force and effect.

SECTION 4. That any person, firm or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred (\$200.00) Dollars for each offense.
