AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING THEMESQUITE ZONING ORDINANCE ADOPTED ON SEPTEMBER 4, 1973, AND RECODIFIED ON NOVEMBER 21, 1988, SO AS TO APPROVE A CHANGE OF ZONING FROM COMMERCIAL MP-SC TO COMMERCIAL MP-SC WITH A CONDITIONAL USE PERMIT FOR AN AMBULANCE AND DISPATCH SERVICE SUBJECT TO CERTAIN STIPULATIONS; REPEALING ALL ORDINANCES CONFLICT WITH THE PROVISIONS OF ORDINANCE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY NOT TO EXCEED TWO THOUSAND (\$2,000.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EMERGENCY.

WHEREAS, the Planning and Zoning Commission of the City of Mesquite and the governing body of the City of Mesquite, in compliance with the Charter of the City of Mesquite and State laws with reference to granting of zoning changes under the Zoning Ordinance Regulations and Zoning Map, have given the requisite notices by publication and otherwise, and after holding due hearings and affording a full and fair hearing to all property owners generally and to the persons interested and situated in the area, the City of Mesquite is of the opinion that the change of zoning may be granted herein; and

WHEREAS, the proposed use of the subject property for ambulance and dispatch services is deemed temporary in nature due to the leasing of building space, by minimal property improvements, and by the lack of construction customized for said use; and

WHEREAS, the proposed use is consistent with current uses in the area and on adjoining property, however, anticipated future changes within the Military Parkway – Scyene Corridor Overlay District will cause the proposed use to become incompatible after a period of time.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the Mesquite Zoning Ordinance adopted on September 4, 1973, and recodified on November 21, 1988, be and the same is hereby amended by amending the Zoning Map of the City of Mesquite so as to approve a change of zoning from Commercial MP-SC to Commercial MP-SC with a Conditional Use Permit to allow for an ambulance and dispatch service subject to the following stipulations:

- 1. No more than six ambulances or transport vehicles shall be stored at or operate from the site.
- 2. All vehicles shall be parked and/or stored within the building.
- 3. The Conditional Use Permit shall be limited to the existing Suite D at 1210 W. Scyene Road and limited to Texas Lifeline Corporation.
- 4. The Conditional Use Permit shall expire on September 21, 2012. Provided that after July 1, 2012, Texas Lifeline Corporation may apply for renewal of the

Conditional Use Permit and such application shall be subject to the same submittal, notification and hearing requirements and procedures as all other conditional use permits.

That the subject property is a 5,200 square-foot lease space located at 1210 W. Scyene Road, Suite D.

SECTION 2. That all ordinances, or portions thereof, of the City of Mesquite in conflict with the provisions of this ordinance, to the extent of such conflict are hereby repealed. To the extent that such ordinances or portions thereof not in conflict herewith, the same shall remain in full force and effect.

SECTION 3. That the property described in Section 1 of this ordinance shall be used only in the manner and for the purposes provided for by the Mesquite Zoning Ordinance.

SECTION 4. That the foregoing change shall be, and it is, granted subject to any development of the land herein being developed in conformity with the requirements of current and/or future drainage improvement ordinances of the City of Mesquite, including Ordinance No. 3042, codified in Chapter 11 of the Code of the City of Mesquite.

<u>SECTION 5.</u> That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional, the remaining provisions of this ordinance shall remain in full force and effect.

SECTION 6. That any person, firm or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and upon conviction in the Municipal Court, shall be punished by a fine not to exceed Two Thousand (\$2,000.00) Dollars for each offense.

SECTION 7. That the property described in Section 1 of this ordinance requires that it be given the above classification in order to permit its proper development and in order to protect the public interest, comfort and general welfare of the City of Mesquite, creates an urgency and emergency for the preservation of the public health, safety and welfare, and requires that this ordinance shall take effect immediately from and after its passage and publication of said ordinance as the law in such cases provides.
