

ORDINANCE NO. 4102

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, REVISING THE CURRENT SCHEDULE OF CHARGES FOR VARIOUS PARKS AND RECREATION SERVICES TO BE EFFECTIVE ON AND AFTER SEPTEMBER 1, 2010; REPEALING ORDINANCE NO. 3996; PROVIDING FOR A SEVERABILITY CLAUSE; AND DECLARING AN EFFECTIVE DATE THEREOF.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:




SECTION 4. That this ordinance shall take effect immediately on and after September 1, 2010.
