

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING CHAPTER 9, SECTION 9-147(1)(a) OF THE CODE OF THE CITY OF MESQUITE, TEXAS, CONCERNING THE LOCATION OF SCHOOL ZONES BY ADDING SCHOOL ZONES FOR ACHZIGER ELEMENTARY SCHOOL AND GENTRY ELEMENTARY SCHOOL; PROVIDING A REPEALER CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EFFECTIVE DATE THEREOF.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Chapter 9, Section 9-147(1)(a) of the Code of the City of Mesquite, Texas, is hereby amended by adding school zones for Achziger Elementary School and Gentry Elementary School to read as follows, in all other respects said Code, Chapter and Section to remain in full force and effect:

<i>School</i>	<i>Location of school zone</i>
Achziger	Ridge Ranch Road approximately 1300 feet west of East Cartwright Road to the end of roadway.
Gentry	Twin Oaks Drive approximately 1250 feet south of East Cartwright Road to a point approximately 2000 feet south of East Cartwright Road.


SECTION 2. That all ordinances or portions thereof in conflict with the provisions of this ordinance, to the extent of such conflict, are hereby repealed. To the extent that such ordinances or portions thereof are not in conflict herewith, the same shall remain in full force and effect.

SECTION 3. That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional, the validity of the remaining provisions of this ordinance shall not be affected and shall remain in full force and effect.

SECTION 4. That any person, firm or corporation violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and upon conviction in the Municipal Court shall be punished by a fine not to exceed Two Hundred (\$200.00) Dollars for each offense.


SECTION 5. That this ordinance shall take effect on and after August 27, 2012.


