ORDINANCE NO. 4335

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS AMENDING CHAPTER 14 OF THE CODE OF THE CITY OF MESQUITE, TEXAS, AS AMENDED, BY DELETING THE RATE TABLE (CHART) IN SECTION 14-45 IN ITS ENTIRETY AND ADDING A NEW RATE TABLE (CHART) IN SECTION 14-45 THEREBY AMENDING THE COMMERCIAL SOLID WASTE COLLECTION RATES; PROVIDING FOR A REPEALER CLAUSE; PROVIDING FOR A SEVERABILITY CLAUSE; AND DECLARING AN EFFECTIVE DATE THEREOF.

WHEREAS, the City Council approved a non-exclusive contract agreement with Republic Services, Inc. (formerly Allied Waste Systems, Inc.), for commercial solid waste collection on September 3, 2013; and

WHEREAS, under provisions of the agreement, Republic Services, Inc., is authorized to adjust commercial solid waste rates each year, effective October 1, based on annual changes in consumer inflation and average retail prices for diesel fuel in the Dallas area as measured by federal government agencies.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Chapter 14 of the Code of the City of Mesquite, Texas, as amended, is hereby amended by deleting the rate table (chart) in Section 14-45 in its entirety and adding a new rate table (chart) in Section 14-45, attached hereto as Exhibit "A" and made a part thereof, in all other respects said Code and Chapter to remain in full force and effect.

SECTION 2. That all ordinances or portions thereof in conflict with the provisions of this ordinance, to the extent of such conflict, are hereby repealed. To the extent that such ordinances or portions thereof are not in conflict herewith, the same shall remain in full force and effect.

SECTION 3. That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional, the remaining provisions of this ordinance shall remain in full force and effect.

SECTION 4. That this ordinance shall take effect immediately on and after October 1, 2014.
