AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, ADOPTING SUPPLEMENT NUMBER 53 (ORDINANCES APPROVED FROM THE FIRST MEETING IN SEPTEMBER 2016 AND EXTENDING THROUGH THE LAST MEETING IN FEBRUARY 2017) TO THE CODE OF THE CITY OF MESOUITE, TEXAS; PROVIDING FOR A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY OR FINE FOR EACH OFFENSE AND VIOLATION OF SAID SUPPLEMENT TO THE SAID CODE; AND DECLARING AN EMERGENCY.

WHEREAS, the Code of the City of Mesquite, Texas, has been revised by adopting Supplement Number 53.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

That Supplement Number 53 (ordinances approved from the first SECTION 1. meeting in September 2016 and extending through the last meeting in February 2017) to the Code of the City of Mesquite, Texas (the "Code"), is hereby adopted, a copy of which is on file in the City Secretary's Department.

That whenever any act under Supplement Number 53 to the Code is SECTION 2. prohibited or is declared to be unlawful or the failure to do any act is declared unlawful; the violation of any provisions of the Code or ordinances governing the dumping of refuse shall be subject to a maximum fine authorized by State law and the City of Mesquite Code of Ordinances, as amended; the violation of any provisions of the Code or ordinances governing fire safety, zoning, public health and sanitation shall be subject to a maximum fine of Two Thousand (\$2,000.00) Dollars and all other Code violations shall be subject to a maximum fine of Five Hundred (\$500.00) Dollars.

That if any phrase, clause, sentence, paragraph or section of this SECTION 3. ordinance or Supplement Number 53 to the Code hereby adopted shall be declared unconstitutional or otherwise invalid by any court of competent jurisdiction, such unconstitutionality or invalidity shall not affect the remaining portions of this ordinance or Supplement Number 53 to the Code.

That the fact that Supplement Number 53 to the Code has not been SECTION 4. adopted, creates an urgency and an emergency in the interest of public health, safety and welfare, and necessitates that this ordinance shall take effect immediately from and after its passage and the publication of the caption of said ordinance as the law and charter in such cases provides.
