

ORDINANCE NO. 5136

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING APPENDIX D – THE COMPREHENSIVE FEE SCHEDULE OF THE MESQUITE CITY CODE BY MAKING CERTAIN DELETIONS AND ADDITIONS IN APPENDIX D FOR FEES COLLECTED BY THE CITY OF MESQUITE FOR THE PURPOSE OF THE CITY COUNCIL’S ANNUAL REVIEW AND UPDATE TO THE CITY’S FEES; REAUTHORIZING ALL BUILDING PERMIT FEES AND OTHER CITY FEES IN ACCORDANCE WITH TEXAS LOCAL GOVERNMENT CODE, CHAPTER 214, SUBCHAPTER Z, SECTION 214.908; PROVIDING FOR A PUBLIC HEARING; PROVIDING A CONFLICTS RESOLUTION CLAUSE; PROVIDING A SEVERABILITY CLAUSE; AND DECLARING AN EFFECTIVE DATE.

WHEREAS, it is the intent of the City Council of the City of Mesquite, Texas (“**City Council**”) to protect the public health, safety, and welfare; and

WHEREAS, the City Council reviews the City’s Comprehensive Fee Schedule annually to ensure the City’s fees are sufficient to cover costs for City services; and

WHEREAS, the City Council finds, determines, and declares that certain fees are necessary to provide for efficient government services; and

WHEREAS, the City Council finds and determines that the current fees are insufficient to cover the costs of the respective services; and

WHEREAS, the City Council desires to adopt fees necessary for the City to provide good and efficient government for the benefit of the citizens of the City; and

WHEREAS, Texas Local Government Code, Chapter 214, Subchapter Z, Section 214.908 (“**Section 214.908**”) requires the City Council to *reauthorize* building permit fees *prior* to the 10th anniversary after the date the fee is adopted or most recently reauthorized; and

WHEREAS, Section 214.908 also requires the City Council to hold a public hearing regarding the reauthorization of any building permit fees; and

WHEREAS, a public hearing was held on this date in accordance with Section 214.908 (b)(1); and

WHEREAS, upon full review and consideration of all matters attendant and related thereto, the City Council is of the opinion this ordinance should be approved and adopted.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. Recitals Incorporated.

The City Council hereby finds and determines the recitals made in the preamble of this ordinance are true and correct, and hereby incorporates such recitals here in the body of this ordinance as if copied in their entirety.

SECTION 2. Mesquite City Code Text Amendment.

APPENDIX D – COMPREHENSIVE FEE SCHEDULE (“**Appendix D**”) of the Mesquite City Code, as amended, is hereby amended by making certain deletions and additions as identified in **EXHIBIT A**, attached hereto and made a part hereof, and in all other respects said Appendix D shall remain in full force and effect.

SECTION 3. Reauthorize Building Permit Fees and All Other Fees.

In accordance with Texas Local Government Code, Chapter 214, Subchapter Z, Section 214.908 (“**Section 214.908**”) the City Council hereby reauthorizes any building permit fees and all other fees as identified in **EXHIBIT A** and in Mesquite City Code, Appendix D – Comprehensive Fee Schedule, as may be amended.

SECTION 4. Public Hearing.

In accordance with Section 214.908 the City Council on this date held a public hearing prior to any formal action on this item.

SECTION 5. Conflicts Resolution Clause.

In the event of an irreconcilable conflict between the provisions of another previously adopted ordinance of the City of Mesquite and the provisions of this Ordinance, the provisions of this Ordinance shall be controlling.

SECTION 6. Severability Clause.

Should any word, sentence, paragraph, subdivision, clause, phrase, or section of this ordinance be adjudged or held to be void or unconstitutional, the same shall not affect the validity of the remaining portions of said ordinance and the Mesquite City Code, as hereby or previously amended, which shall remain in full force and effect.

SECTION 7. Effective Date.

This Ordinance goes into effect immediately from and after its passage.
