## ORDINANCE NO. 189


#### Abstract

AN ORDINANCE AMENDING ORDINANCE NO. 120 ENACTED BY THE CITY COUNGIL ON MAY 3, 1955, BY PERMITTING THE FOLLOWING DESCRIBED PROPERTY WHICH IS PRESENTLY ZONED LOCAL RETAIL "LR", TO WIT: LOT, TRACT OR PARCEL OF LAND SITUATED IN DALLAS COUNTY, TEXAS, AND BEING A. PART OF THE DANIEL TANNER SURVEY, ABSTRACT NO. 1462 BEGINNING AT THE INTERSEGTION OF THE NORTHWEST LINE OF THE S. H. MILLER SURVEY ABSTRACT NO. 947, WITH THE SOUTH LINE OF MILITARY PARKWAY; THENCE SOUTH 45 DEGREES WEST WITH THE NORTHWEST LINE OF SAID S. H. MILLER SURVEY, AND ALONG AN OLD ESTABLISHED FENGE LINE, 411.8 FEET TO A POINT FOR CORNER; IN THE EAST LINE OF HICKORY T REE ROAD; THENCE NORTH WITH THE EAST LINE OF THE HICKORY TREE ROAD, AND ALONG A FENCE 278 FEET TO A POINT FOR CORNER; THENCE NORTH 47 DEGREES 11 MINUTES EAST WITH A FENGE LINE, 40.83 FEET TO A POINT FOR CORNER IN THE SOUTH LINE OF MILITARY EXPRESSWAY; THENCE SOUTH 86 DEGREES 48 NINUUTES 30 SECONDS EAST WITH SAID LINE OF MILITARY EXPRESSWAY AND ALONG A FENCE 261. 74 FEET TO THE PLACE OF BEGINNING AND OONTAINING 1.0174 ACRES OF LAND, TO BE USED FOR THE CONST RUCTION AND OPERATION OF AN AUTO REPAIR GARAGE UNDER A SPECLAL PERMIT, SUBJECT, HOWEVER, TO THE SPE CLAL CONDITIONS HEREINAFTER MORE FULLY EXPRESSED; THAT THE PROPERTY SHALL BE IMPROVED ACCORDING TO THE PLANS AND SPEGIFIGATIONS SUBMITTED THEREFOR AND APPROVED BY THE CITY PLANNING AND ZONING COMMISSION AND THE CITY COUNCIL; PROVIDING FOR PENALTY; AND DECLARING AN EMERGENCY.


Whereas, the City Planning and Zoning Commission of the City of Mesquite and the Governing Body of the City of Mesquite in compliance with the Charter of the City of Mesquite and the State Law with reference to the granting of Special Permit under the Zoning Ordinance regulations and zoning map have given the requisite notices by publications and otherwise and after holding due hearing and affording a full and fair hearing to all property owners, generally, and to the persons interested situated in the affected area and in the vicinity thereof, the governing body of the City of Mesquite is of the opinion that said Special Permit should be granted, subject to the conditions set out herein.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Ordinance No. 120 enacted by the City Council on May 3, 1955 be and is hereby amended insofar as the hereinafter described property is concerned, which is presently zoned Local Retail, shall be used under a Special Permit for the construction and operation of an auto repair garage, subject to the special conditions contained herein:

Lot，tract or parcel of land situated in Dallas County，Texas，and being a part of the Daniel Tanner Survey，Abstract．No． 1462 beginning at the intersection of the Northwest line of the S．H．Miller Survey， Abstract No．947，with the South line of Military Expressway；thence South 45 degrees West with the Northwest line of said S．H．Miller Survey，and along an old established fence line， 411.8 feet to a point for corner；in the Eastline of Hickory Tree Road；thence North with the East line of the Hickory Tree Road，and along a fence 278 feet to a point for corner；thence North 47 degrees 11 minutes East with a fence line， 40.83 feet to a point for corner in the South line of Military Parkway；thence South 86 degrees， 48 minutes 30 seconds East with said line of Military Parkway and along a fence， 261.74 feet to the place of beginning and containing 1.0174 acres of land．

SECTION 2．That this Special Permit for the construction and operation of an auto repair garage on the hereinabove described property is approved and granted uponthe following express conditions and in accordance with Section 4 of the Zoning Ordinance．
（1）That the site plan for the construction and operation of an auto repair garage shall be approved by the City Planning and Zoning Commission and shall be generally in conformance therewith．Such approved site plan may be revised or amended if such revision or amendment thereof is first approved by the City Planning and Zoning Commission．
（2）At such time as all proposed buildings are completely constructed，off－street parking facilities shall be provided，as indicated on the approved site plan．
（3）That all means of ingress and egress shall be as indicated on the approved site plan．
（4）That all streets，service drives，parking areas and alleys shall be paved and drainage structures and curbs and gutters installed in accordance with the City of Mesquite requirements and as indicated on the approved site plan and that the developer shall bear the total cost of all such improvements．
（5）That no signs or billboards other than those pertaining to the occupancy of the premises or commodities sold thereon shall be permitted and such allowable signs shall be of the parapet wall，maxquee or flat wall type，except for a gasoline fill ing station a standard pole sign not exceeding 36 square feet shall be permitted for the filling station．That the location of any sign other than as stated above shall be first approved by the City Planning and Zoning Commission．
（6）That all work shall be conducted inside the building and does not include the open storage of vans，trailers or trucks．

Ordinance No. 18:
SECTION 3. That any person, firm or corporation violating any of the terms and provisions of this Ordinance shall be subject to the same penalties provided for in Ordinance No. 120.

SECTION 4. WHEREAS, it appears that the subject property of this ordinance is to be used under a Special Permit for the construction and operation of an auto repair garage, subject to certain conditions and will serve the public interest, comfort and general welfare and requires that this Ordinance shall take effect immediately from and after its passage and it is accordingly so ordained.
