## ORDINANCE NUMBER 486

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, ABANDONING AN EASEMENT FOR STREET PURPOSES GRANTED BY CAROLINE HUNT TRUST ESTATE ON DECEMBER 29, 1961, WITH SAID EASEMENT LOCATED BETWEEN TEXAS & PACIFIC RAILROAD COMPANY RIGHT-OF-WAY AND FORMEY ROAD IN THE DANIEL TANNER LEAGUE, ABSTRACT NO. 1462, DALLAS COUNTY, TEXAS, AND AUTHORIZING THE MAYOR AND THE CITY SECRETARY OF THE CITY OF MESQUITE, TEXAS, TO EXECUTE AN INSTRUMENT OF ABANDONMENT OF SAID EASEMENT.

WHEREAS, On December 29, 1961, Caroline Hunt Trust Estate, whose Trustee is J. A. Goodson, at the request of the City of Mesquite, Texas, granted a certain 100-foot Easement for street purposes to the City of Mesquite, Texas, with said Easement being located between Texas & Pacific Railroad Company Right-of-way and Forney Road in the Daniel Tanner League, Abstract No. 1462, Dallas County, Texas, and said Easement being fully described in an instrument recorded in Volume 5700, page 579 of the Deed Records of Dallas County, Texas, to which reference is herewith made.

WHEREAS, it is now the desire and the requirement of the City of Mesquite, Texas, that the proposed street that would have been located on said Easement must be relocated, and therefore, said Easement, which has never been used for the purpose for which it was granted, is of no further use or benefit to the City of Mesquite, Texas.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, that the City of Mesquite, Texas, hereby abandons, releases and discharges any and all public or municipal right in the aforesaid Easement and the Mayor and the City Secretary are hereby authorized and empowered to execute all instruments of abandonment.
