## ORDINANCE No. 2396

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, PROVIDING FOR THE ABANDONING OF OUTFALL NO. 6A EASEMENT-EAST AND OUTFALL NO. 6 EASEMENT-EAST IN CREEK CROSSING ESTATES NO. 12 PHASE 1; CITY OF MESQUITE, DALLAS COUNTY, TEXAS, AS DESCRIBED IN EXHIBITS "A" AND "B" HERETO AND AUTHORIZING THE MAYOR TO EXECUTE A QUIT CLAIM DEED; AND PROVIDING AN EFFECTIVE DATE THEREOF.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the Outfall No. 6A Easement-East and Outfall No. 6 Easement-East in Creek Crossing Estates No. 12 Phase 1, City of Mesquite, Dallas County, Texas, as described in Exhibits "A" and "B" attached hereto, shall be, and the same are hereby abandoned.

SECTION 2. That Mayor Brunhilde Nystrom is hereby authorized to execute a quit claim deed to effect such abandonment to Baker & Associates No. 1 Joint Venture.

SECTION 3. The fact that the orderly development of the City of Mesquite requires the easements be abandoned creates an urgency and an emergency and necessitates that this ordinance become effective immediately from and after its date of passage and the publication of its caption as the law in such cases provides.




