

ORDINANCE NO. 5147

AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING CHAPTER 9, SECTION 9-147 OF THE MESQUITE CITY CODE BY DELETING A CERTAIN SCHOOL ZONE UNDER SECTION 9-147(1)(c) AND ADDING A NEW SECTION 9-147(1)(f) TO PROVIDE A REVISED SCHOOL ZONE FOR TRINITY BASIN PREPARATORY; PROVIDING A REPEALER CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY NOT TO EXCEED \$500.00 FOR EACH OFFENSE; PROVIDING PUBLICATION OF THE CAPTION HEREOF; AND DECLARING AN EFFECTIVE DATE THEREOF.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

**SECTION 1.** That Chapter 9, Section 9-147 of the Mesquite City Code is hereby amended by deleting a certain school zone under Section 9-147(1)(c) and adding a new Section 9-147(1)(f) to provide a revised school zone for Trinity Basin Preparatory to read as follows, in all other aspects said Code, Chapter, and Sections to remain in full force and effect:

- (1) *Section 9-147(1)(c).* Amend by deleting the school zone for Trinity Basin Preparatory in its entirety under Section 9-147(1)(c).
- (2) *Section 9-147(1)(f).* Amend by adding a new Section 9-147(1)(f) for the revised school zone for Trinity Basin Preparatory to read as follows:
  - (f) School zone times for the following designated school location is from 7:00 a.m. – 7:50 a.m. and from 3:15 p.m. – 4:00 p.m.

<i>School</i>	<i>Location of school zone</i>
Trinity Basin Preparatory	East Meadow Boulevard from 150 feet north of Action Drive to 100 feet south of Flamingo Way

**SECTION 2.** That all ordinances or portions thereof in conflict with the provisions of this ordinance, to the extent of such conflict, are hereby repealed. To the extent that such ordinances or portions thereof are not in conflict herewith, the same shall remain in full force and effect.

**SECTION 3.** That should any word, sentence, clause, paragraph, or provision of this ordinance be held to be invalid or unconstitutional, the validity of the remaining provisions of this ordinance shall not be affected and shall remain in full force and effect.

SECTION 4. Any violation of the provisions or terms of this Ordinance by any “person,” as defined in Mesquite City Code, Chapter 1, [Section 1-2](#), shall be deemed a Class C Misdemeanor criminal offense, and upon conviction thereof, shall be subject to a penalty of fine, or any other general penalties, as provided in Mesquite Zoning Ordinance, Part 5, 5-100, [Section 5-103](#) (General Penalties), or successor and as amended.

SECTION 5. This Ordinance shall be published in the City’s official newspaper in accordance with Mesquite City Charter, Article IV, [Section 24](#).

SECTION 6. This Ordinance shall take effect and be in force from and after five days after publication.
