PUBLIC HEARINGS.

21. PUBLIC HEARING – ZONING – APPLICATION NO. 1461-144-2009 SUBMITTED BY F. MICHAEL GRAVES FOR A ZONING CHANGE FROM LIGHT COMMERCIAL WITH A CONDITIONAL USE PERMIT TO LIGHT COMMERCIAL WITH A REVISED CONDITIONAL USE PERMIT TO ALLOW FOR THE SALE OF USED CARS, OR IN THE ALTERNATIVE TO COMMERCIAL WITH A CONDITIONAL USE PERMIT TO ALLOW FOR THE SALE OF USED CARS AND MINIWAREHOUSES LOCATED AT 1919 OATES DRIVE – POSTPONED UNTIL THE OCTOBER 5, 2009, CITY COUNCIL MEETING.

A public hearing was held to consider Application No. 1461-144-2009 submitted by F. Michael Graves for a zoning change from Light Commercial with a Conditional Use Permit to Light Commercial with a revised Conditional Use Permit to allow for the sale of used cars, or in the alternative to Commercial with a Conditional Use Permit to allow for the sale of used cars and miniwarehouses. This property is further described as a 7.95-acre tract located at 1919 Oates Drive.

Applicant F. Michael Graves presented the application and expressed concern regarding three of Planning and Zoning Commission's recommended stipulations. He stated that his first concern is the recommendation to install ten new landscaped parking islands. Mr. Graves stated that the company would rather install additional landscaping along Oates Drive which they feel would be more beneficial since it is a highly visible area. He stated that a revised site plan was submitted to the Planning and Zoning staff just prior to today's City Council meeting.

Mr. Graves stated that he is also concerned about the recommendation limiting the maximum number of vehicles on this site to 150. He stated that the property currently contains 479 parking spaces and the dealership would like to utilize this space for displaying additional vehicles. Another concern is Planning and Zoning Commission's recommendation that no vehicle may be over four years old. Mr. Graves explained that this is a Ford dealership and Ford Motor Company prohibits financing vehicles over five years old or vehicles with more than 100,000 miles. Mr. Graves explained that, at this time, several new vehicles are for sale on the lot to keep from violating the zoning requirements now in place. However, due to an agreement with certain auto-makers, new vehicles are prohibited from being sold at this location. The dealership has received a temporary exemption from Ford Motor Company to sell new vehicles until the zoning situation can be resolved. Therefore, Mr. Graves is requesting approval to sell up to 100 percent used vehicles that are no more than five years old.

Mr. Graves stated that his request for miniwarehouses was initiated by individuals contacting him regarding storage for classic show cars and similar vehicles. However, he agrees to dismiss this request.

No one appeared regarding the proposed zoning change. Mayor Monaco declared the public hearing closed.

Councilmembers expressed concern regarding utilizing this site, which is a gateway into the City, for the sale of used vehicles and that the revised site plan had not been submitted prior to today's meeting to allow staff and Council adequate time for review.

Mr. Tarpley moved to postpone Application No. 1461-144-2009 submitted by F. Michael Graves for a zoning change from Light Commercial with a Conditional Use Permit to Light Commercial with a revised Conditional Use Permit until the October 5, 2009, City Council meeting. Motion was seconded by Ms. Roberts and approved unanimously.

22. <u>PUBLIC HEARING – ZONING – APPLICATION NO. 1462-265-2009</u> <u>SUBMITTED BY DANNY GAMEZ AND ORDINANCE NO. 4061 FOR A</u> <u>ZONING CHANGE FROM INDUSTRIAL TO INDUSTRIAL WITH A</u> <u>CONDITIONAL USE PERMIT TO ALLOW FOR THE SALE OF USED FORKLIFTS</u> <u>AND THE OUTDOOR DISPLAY OF FORKLIFTS LOCATED AT 3510 E. US</u> <u>HIGHWAY 80 – APPROVED WITH CERTAIN STIPULATIONS.</u>

A public hearing was held to consider Application No. 1462-265-2009 submitted by Danny Gamez for a zoning change from Industrial to Industrial with a Conditional Use Permit to allow for the sale of used forklifts and the outdoor display of forklifts. This property is further described as a 1.3109-acre tract located at 3510 E. US Highway 80.

Applicant Danny Gamez, Texas Forklift, presented the application and stated that the proposed use is for a start-up business selling new and used forklifts in a 15,950-square-foot warehouse building. The Planning and Zoning Commission recommended that the proposed outdoor display be located along Presidential Row; however, he requested approval for outdoor display along the frontage road of US Highway 80. Mr. Gamez stated that approximately 15 forklifts can be stored inside the building and is requesting five of these be displayed outside.

No one appeared regarding the proposed zoning change. Mayor Monaco declared the public hearing closed.

Councilmembers expressed opposition to the request for outdoor display at this location.

Mr. Pickett moved to approve Application No. 1461-144-2009, as recommended by the Planning and Zoning Commission, with the following stipulations:

- 1. Used forklifts shall account for no more than 40 percent of the forklift inventory. It shall not include the sale of any other used merchandise.
- 2. Outside display of new or used forklifts shall be prohibited.
- 3. No signs, banners or balloons of any kind may be placed on the property with the following exceptions:
 - a. One monument sign.
 - b. Wall signs.
 - c. One flag pole.
 - d. Directional/instructional signage as needed. Such signage shall not include advertising.
 - e. Signs must comply with City sign ordinance.
- 4. Site development shall conform to the Concept Plan. The improvements shown on the Concept Plan shall be made prior to issuing the Certificate of Occupancy.
- 5. This Conditional Use Permit is limited to the applicant, Texas Forklift, and is not transferable to a different person or business entity.
