PRE-MEETING - CITY COUNCIL CONFERENCE ROOM - NOON.

The City Council met in the City Council Conference Room beginning at Noon to discuss the items on the Regular Agenda and receive briefing regarding: (1) the fifth annual Real. Texas. Festival., (2) proposed changes to cable television Public, Education and Government (PEG) Access channel programming and (3) discuss Mesquite Education Foundation fundraiser.

EXECUTIVE SESSION - CITY COUNCIL CONFERENCE ROOM - 12:38 P.M.

The City Council met in Executive Session pursuant to Section 551.072 of the Texas Government Code to discuss the purchase, exchange, lease or value of real property (Acquisition of property near the Mesquite Metro Airport); whereupon, the City Council proceeded to meet in the City Council Conference Room. After the closed meeting ended at 12:53 p.m., the City Council reconvened in Open Session.

The Pledge of Allegiance was led by Recreation After School Program participants from Goodbar Recreation Center.

SPECIAL ANNOUNCEMENT.

Mayor Monaco announced that the City of Mesquite was one of only 14 Texas cities to be recognized as a Texas Certified Scenic City by the Scenic Texas organization. This designation was earned by adopting some of the State's strictest scenic standards for public roadways and spaces. The City of Mesquite's Silver-level certification places it in the second highest ranked group of cities recognized. Mayor Monaco acknowledged the efforts of the Parks and Recreation Department, Keep Mesquite Beautiful, Inc., Planning, Environmental Code, Building Inspection and Solid Waste whose work contributed to Mesquite being recognized as a Texas Certified Scenic City.

CITIZENS FORUM.

Jason Motter, 3832 Glasgow Drive, Plano, representing CIGNA Healthcare, spoke regarding Consent Agenda Item No. 9, RFP No. 2010-071 – Medical Coverage. He

stated that CIGNA has represented the City of Mesquite for the past nine years and is a national carrier insuring over 10 million lives. He summarized CIGNA benefits and asked that all aspects be analyzed equally.

Mr. Pickett moved to reappoint Jack Akin, Place 2, and Richard Allen, Jr., Place 6, as regular members of the Planning and Zoning Commission/Capital Improvements Advisory Committee and to change the appointment of Donna Adams from an alternate member of the Planning and Zoning Commission/Capital Improvements Advisory Committee to a regular member, Place 4, all for terms to expire September 30, 2012. Motion was seconded by Mr. Porter and approved unanimously.

Mr. Pickett amended his motion to include reappointing Tony Franklin as a member of the Capital Improvements Advisory Committee for a term to expire September 30, 2012. Mr. Porter amended his second and the motion was approved unanimously.

Mr. Pickett moved to adjourn the meeting. Motion was seconded by Mr. Hutcheson and approved unanimously. The meeting adjourned at 3:31 p.m.
