- (1) <u>Discuss concerns over misuse of 'K2'.</u> Discussed. Council directed staff to prepare an ordinance banning the sale, possession or use of K2 in the City of Mesquite.

It was Council consensus to look at additional budget scenarios and requested the City Manager develop some budget options for consideration, including an option with a one-percent property tax increase.
