That said election was duly called; that notice was given in accordance with law and in accordance with the resolution calling the election; that the election was held in accordance with law; that due return of said election has been made by the proper officers; that of the resident, qualified electors who own taxable property in said City and who had duly rendered the same for taxation and voted at said election, a majority voted in favor of the issuance of all of the aforesaid bonds.
- 2. That the City Council is in all things authorized to issue all of the aforesaid bonds and to do any and all things necessary or convenience in connection therewith.
