WHEREAS, there presently exists hazardous traffic situations at the intersections of Florence and Gross Road with the Texas & Pacific railroad \*"acks: and

WHEREAS, the best and most practical method of reducing the now hazardous traffic situation at the aforesaid locations is by the installation of mechanical gates; and

WHEREAS, the Texas & Pacific Railway Company has agreed to cause to be installed at such locations mechanical gate crossings; and

WHEREAS, the installation of such mechanical gate crossings at the locations aforesaid is the best and n ost practical method of alleviating the hazardous traffic situations now existing and will materially improve the traffic safety problem posed by motor vehicle and railroad traffic under current conditions within the City of Mesquite.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

Section 1. That the Mayor is hereby authorized to enter into the contract, attached hereto and made a part of this resolution, with the Texas & Pacific Railway Company on behalf of the City of Mesquite.

Section 2. That in substance this contract shall provide that the Texas & Pacific Railway Company agrees to install mechanical gate crossings at the intersections of Florence and Gross Roads with that company's railroad tracks at an extimated cost of sixteen thousand dollars (\$16,000.00); that upon the satisfactory completion of such installation, the City shall reimburse the Texas & Pacific Railway Company in the amount of eight thousand dollars (\$3,000.00).

Section 3. That this resolution shall take effect immediately from and after its date of passage.



THIS AGREEMENT executed this <u>f</u> day of <u>Augus</u> 1968, by and between the CITY OF MESQUITE, TEXAS, a municipal corporation, hereinafter called "CITY", and THE TEXAS AND PACIFIC RAILWAY COMPANY, a corporation created and existing under and by virtue of Acts of Congress of the United States, hereinafter called "RAILWAY", WITNESSETH:

WHEREAS, CITY and RAILWAY have considered and discussed the type of traffic control devices which should be utilized at RAILWAY'S Florence Street and Gross Road crossings in the City of Mesquite, Texas, and

WHEREAS, RAILWAY, having due regard for the safety and convenience of the traveling public, has installed flasher light traffic control devices at said Florence Street and Gross Road crossings, which RAILWAY considers adequate to eliminate any danger to the traveling public at these locations; and

WHEREAS, CITY desires the installation of crossing gates at said locations;

NOW THEREFORE, for and in consideration of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

> 1. RAILWAY shall install protective crossing gates at the intersections of RAILWAY'S
