

RESOLUTION NO. 19-70

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, AUTHORIZING THE CITY MANAGER TO MAKE PAYMENT IN THE APPROXIMATE AMOUNT OF \$22,669.00 TO DALLAS COUNTY UPON COMPLETION AND ACCEPTANCE OF CERTAIN EXTRA WORK REQUESTED BY THE CITY OF MESQUITE ON THE TOWN EAST BOULEVARD PROJECT AS SHOWN BY CHANGE ORDER NO. 1 TO BID NO. 69-169.

WHEREAS, the City Council authorized Dallas County to do certain extra work on Town East Boulevard in the City of Mesquite, Texas.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the City Manager be authorized to make payment to Dallas County in an approximate amount of \$22,669.00, upon completion and acceptance of certain extra work requested by the City of Mesquite on the Town East Boulevard Project as shown by Change Order No. 1 to a certain contract between the County of Dallas and Dalstrom Corporation dated September 25, 1969, in the original amount of \$736,751.00 and designated on the Minutes of the Commissioners Court as Bid No. 69-169, a copy of which is attached and made a part of this resolution.

SECTION 2. That this resolution shall take effect immediately from and after its date of passage.

CHANGE ORDER NO. 1
BID NO. 69-169

1. Description of Changes:

- a. To change the centerline location of the proposed box culvert to seven (7) feet west of the existing centerline of Gus Thomasson Road right-of-way. (Cost - \$923.00)
- b. Sidewalks five feet in width should be constructed adjacent to the curb along the south side of Towneast, in its entire length from Gross Road to IH 635. Sidewalks four feet in width should be constructed along the north side of Towneast, from 120 feet west of Edgebrook Drive to Gus Thomasson Road. Construction of five-foot sidewalks along the south side of the street amounts to approximately 6,250 linear feet, or 3,472 square yards. Construction of four-foot sidewalks along the North side of the street amounts to approximately 1,120 linear feet, or 500 square yards. *Cost \$21,846*

2. Reason for Changes:

- a. Topographical features of the area adjacent to the proposed box culvert would result in cantilevering the sidewalk over the existing drainage ditch. To alleviate this structural problem, a small adjustment of the proposed culvert has been figured. It was jointly determined that it is in the best interest of the County of Dallas and the City of Mesquite to adjust the alignment as shown on the attached drawings 70033-10, and 69028-45 through 69028-51, inclusive.
- b. Due to the fact that sidewalks are more readily constructed as a part of the said project, the City of Mesquite requested that the sidewalk construction proposed above be accomplished under the contract between Dallas County and Dahlstrom Corporation.

3. Effect of Change:

All materials and labor needed for fulfillment of this change order will be performed at an additional expense to the County. However, the City of Mesquite will reimburse the County of Dallas the estimated amount for the additional work on sidewalk installations, as well as the adjustment differences of the proposed box culvert.
