WHEREAS, the City of Garland, Texas, has disannexed a certain tract of land at the request of the City of Mesquite; and,

WHEREAS, it is the intention of the City of Mesquite, Texas, to annex the tract of land disannexed by the City of Garland, Texas; and,

WHEREAS, the City of Dallas, Texas, has heretofore annexed a ten (10) foot wide strip of land between the City of Mesquite, and the land to be annexed; and,

WHEREAS, in order to comply with State law it is necessary that the boundries of the City of Mesquite and the land to be annexed be contiguous; and,

WHEREAS, in order to accomplish the foregoing it is necessary that the City of Dallas, Texas, disannex the aforementioned ten (10) foot wide strip of land and annex another ten (10) foot wide strip of land ajacent to the boundry of the City of Garland and out of the sixty-two (62) acre tract disannexed by the City of Garland at the request of the City of Mesquite;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the City of Mesquite, Texas, hereby authorizes and requests the City of Dallas, Texas, to disannex the following described tract of land, hereinafter called Tract One, to Wit:
