RESOLUTION NO. 26-72

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, DETERMINING THAT CERTAIN LAND DESCRIBED HEREIN IS NO LONGER NEEDED FOR USE OF CITIZENS AS A ROAD AND DECLARING THE CITY'S ACCEPTANCE OF THE STATES PROPOSAL TO SELL SUCH LAND AS SURPLUS RIGHT-OF-WAY AND PROVIDING THE EFFECTIVE DATE THEREOF.

WHEREAS, certain right-of-way was acquired by the State of Texas for use in construction of Interstate Highway 635; and

WHEREAS, such right-of-way as not needed as a part of the State highway system or as a City thoroughfare and should be returned to private ownership;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the City Council of the dity of Meaquite has determined that the land described in Exhibit "A" attached hereto and made a part of this instrument no longer is needed for use of citizens as a road and does he eby declare that the States proposed action to sell such land as surplus is acceptable to the City of Mesquite.

SECTION 2. That this Resolution take effect immediately upon date of passage as the law in such cases provides.



Situated in the S. H.
