NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the City Council of the City of Mesquite supports the efforts of the Texas State Highway Commission to maintain and improve the highway system of this State and do hereby express their appreciation for the work being done by the Commission and do state their support for future endeavors of the Commission.

SECTION 2. That the City of Mesquite, Texas, respectfully requests further consideration by the State Highway Department of the following needed projects within the City of Mesquite, Texas:

- A. Installation of signalization equipment for the intersections of:
 - Military Parkway @ the East (northbound) frontage road of Interstate Highway 635.
 - Scyene Road @ the East (northbound) frontage road of Interstate Highway 635.
 - Scyene Road @ the West (southbound) frontage road of Interstate Highway 635.
- B. Construction of entrance and exit ramps between the City major thoroughfares and Interstate systems as follows:
 - 1. New Market @ Interstate Highway 635:
 - a. Entrance ramps to Northbound and Southbound Interstate Highway 635

- b. Exit ramps from Northbound and Southbound Interstate Highway 635
- 2. Gus Thomasson Road @ Interstate Highway 635:
 - a. Exit ramp from Northbound Interstate Highway 635 south of Gus Thomasson
 - b. Entrance ramp to Southbound Interstate Highway 635 south of Gus Thomasson
- 3. La Prada @ Interstate Highway 635:
 - Exit ramp from Northbound Interstate Highway 635 south of La Prada
 - b. Entrance ramp to Southbound Interstate Highway 635 south of La Prada
- 4. Gus Thomasson @ Interstate Highway 30:
 - Exit ramp from Westbound Interstate Highway 30 east of Gus Thomasson
 - Entrance ramp to Eastbound Interstate Highway 3G
- 5. Gus Thomasson @ U.S. Highway 80:
 - a. Exit ramp from Eastbound U.S. Highway 80 west of Gus Thomasson
 - Entrance ramp to Westbound U.S. Highway 80 east of Gus Thomasson
- C. Installation of a continuous lighting system for U.S. Highway 80 and Interstate Highway 30 from East to West City limits.
- D. Improvements of drainage structures and facilities at the following locations:
 - 1. U.S. Highway 80 east of Parkside Orive
 - 2. South Mesquite Creek @ Interstate Highway 635
- E. Construction of bridge structure and connection of existing Service Roads at Lee Street just south of U. S. Highway 80.
