A JOINT RESOLUTION OF THE BOARD OF DIRECTORS OF THE MESQUITE CHAMBER OF COMMERCE AND THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, ADOPTING A POSITION WITH REFERENCE TO THE PROPOSED 1973 DALLAS COUNTY THOROUGHFARE IMPROVEMENT BOND PROGRAM AND THE PROPOSED DALLAS COUNTY BOND ELECTION AND DECLARING AN EFFECTIVE DATE THEREOF.

WHEREAS, the proposed 1973 Dallas County Thoroughfare Improvement Bond Program and the proposed Dallas County Bond Election is needed for the continued progress of the excellent thoroughfare program in Dallas County; and

WHEREAS, a County-wide program of thoroughfare improvement is beneficial to the respective cities in Dallas County by providing inter- and intra-city traffic patterns and lessening the burden of the individual city in this field; and

WHEREAS, the Mesquite Chamber of Commerce and the City of Mesquite have traditionally favored and supported cooperation with Dallas County and other political entities; and

WHEREAS, it is not the desire of the Board of Directors of the Mesquite Chamber of Commerce or the City Council of the City of Mesquite to delay or hinder the worthwhile projects of this program, but rather seek an equitable distribution of projects throughout the County; and

WHEREAS, Mayor Bob Beard has worked tirelessly and diligently to bring about agreement of all parties to this important program.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE MESQUITE CHAMBER OF COMMERCE AND THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the Board of Directors of the Mesquite Chamber of Commerce and the City Council of the City of Mesquite, Texas, cannot support the proposed 1973 Dallas County Thoroughfare Improvement Bond Program in its present form for the following reasons:

Inadequate consideration is given to certain areas of the County, particularly the area encompassed by the City of Mesquite.

Specifically the projects allocated for the City of Mesquite do not equitably distribute the total funds to be derived from such bond program and deprive the citizens of this area of equal benefits when compared to other areas of Dallas County.

SECTION 2. The following position is therefore taken by the Board of Directors of the Mesquite Chamber of Commerce and the City Council of the City of Mesquite, Texas:

The Board of Directors of the Mesquite Chamber of Commerce and the City Council of the City of Mesquite support the concept of political entities working together for the common good of their citizens and express the hope that this matter may be amicably resolved.

For the citizens of this area to derive equitable benefits so that the Board of Directors of the Mesquite Chamber of Commerce and the City Council of the City of Mesquite can support the bond program, it is hereby resolved that an additional \$2,000,000 should be allocated to be applied to the improvement of Scyene Road from Phillip Street to Berry Road.

SECTION 3. That this Resolution shall take effect immediately upon passage as the Charter in such cases provides.

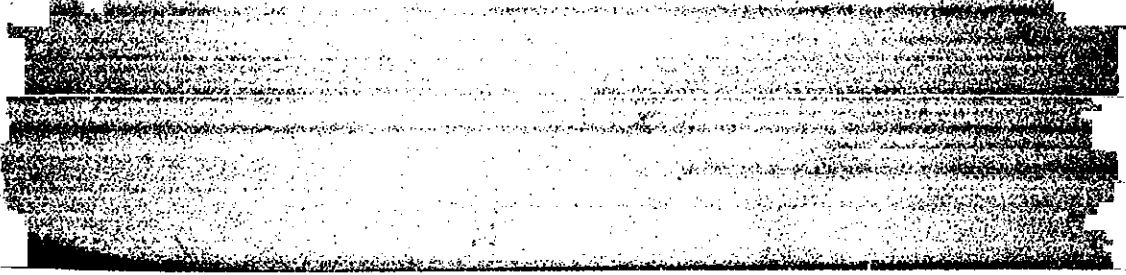
