RESOLUTION NO. 13-76

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, ESTABLISHING A CITY-WIDE PLANNING COMMITTEE AND PROVIDING AN EFFECTIVE DATE THEREOF.

WHEREAS, the rapid growth in size and population experienced by the City of Mesquite is expected to continue in the future; and

WHEREAS, a substantial portion of the land area in the City of Mesquite is currently undeveloped; and

WHEREAS, the foregoing factors present the opportunity to plan for the quality of future development in the City of Mesquite; and


WHEREAS, the citizens of Mesquite are best qualified to determine the future of their community;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That a city-wide planning committee be established, representing a cross-section of those effecting or affected by development, initial membership to be as shown in Exhibit "A" attached hereto, and to be determined by the City Council from time to time as the needs of the City may require, to participate in a planning workshop process to study the future growth and development of the City of Mesquite and to propose policies to encourage the desired type and quality of development.

SECTION 2. That this resolution take effect immediately upon date of passage as the law in such cases provides.
