A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, AUTHORIZING MAYOR BOB BEARD TO EXECUTE A CONTRACT WITH UNITED AERIAL MAPPING OF SAN ANTONIO, TEXAS, FOR CERTAIN AERIAL MAPPING WORK IN AN AMOUNT NOT TO EXCEED \$16,000.00 AND DECLARING THE EFFECTIVE DATE THEREOF.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Mayor Bob Beard is hereby authorized to execute a contract with United Aerial Mapping of San Antonio, Texas, in an amount not to exceed \$16,000.00, to be funded under the City of Mesquite Community Development Block Grant Program, for mapping services in the Southwest Mesquite Drainage Project as indicated on the attached exhibit.

SECTION 2. That this resolution shall take effect from and after its passage as the Charter in such cases provides.



A STATE OF THE STA

In preparation for the forthcoming extensive drainage project in Southwest Mesquite, Engineering has studied the requirements and needs for additional and more current maps in the area. Generally, the area to be updated is approximately 8.6 square miles and includes such refinements as a closer contour interval as well as larger scale maps for design purposes.

Based upon the needs developed, a set of detailed specifications along with requests for proposals were sent to four aerial mapping firms. Response was excellent and four proposals, either in writing or by telephone (to be confirmed in writing) were received by the established dead in December 14, 1976. General scope of the package requested is as follows:

- (*) 1. 10 24" x 36" topographic maps on mylar (1"=200')
 - 2. 10 24" x 36" reproducible aerial photographic maps on mylar (1"=200')
 - 1 36" x 42" topographic map on mylar (1"=500')
 - 4. 32 24" x 36" topographic maps, pencil manuscript (1"=50')
- (*) This item also includes ground control surveys for both horizontal and vertical control.
