

## RESOLUTION NO. 22-77

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, COMMENDING DR. BYRON MCCLENNEY AND THE STAFF OF EASTFIELD COLLEGE FOR THEIR COOPERATION AND ASSISTANCE IN MAKING CAMPUS FACILITIES AVAILABLE TO THE CITY OF MESQUITE FOR USE BY THE MESQUITE SOCCER ASSOCIATION; AND DECLARING THE EFFECTIVE DATE THEREOF.

WHEREAS, in August, 1973, Eastfield College granted the City of Mesquite permission to use five soccer fields on the Eastfield College campus; and

WHEREAS, twenty-three teams participated in the 1973 Fall Soccer League using the Eastfield College soccer fields; and

WHEREAS, Eastfield College now provides grounds for 19 soccer fields and more than 200 youth and adult soccer teams participated in the 1977 Spring Soccer League; and

WHEREAS, Dr. Byron McClenney and the Staff of Eastfield College have graciously allowed the use of the campus grounds and have also provided parking facilities, security, and the many other necessities incidental to a soccer program of this magnitude; and

WHEREAS, the facilities and services provided by Eastfield College to the Mesquite Soccer Association and to the City of Mesquite's Parks and Recreation program represent a significant cost saving to the City of Mesquite; and

WHEREAS, the willingness of Dr. McClenney and the Staff of Eastfield College to participate in this venture with the City of Mesquite benefits the citizens of Mesquite and is worthy of recognition;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:




