

RESOLUTION NO. 14-79

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, DETERMINING THAT A PUBLIC NECESSITY EXISTS FOR THE ACQUISITION OF A FEE SIMPLE TITLE AND/OR EASEMENT TO CERTAIN LAND FOR THE CONSTRUCTION, AND MAINTENANCE OF A COMPREHENSIVE DRAINAGE PROJECT, IN THE SHERWOOD FOREST AREA, IN AND WITHOUT THE CORPORATE LIMITS OF THE CITY OF MESQUITE, TEXAS, AS DESCRIBED HEREIN; AUTHORIZING THE CITY ATTORNEY TO INSTITUTE CONDEMNATION PROCEEDINGS; AND PROVIDING AN EFFECTIVE DATE THEREOF.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the City Council of the City of Mesquite, Texas, has and does deem it necessary and expedient and has determined that a public necessity exists for the acquisition of fee simple title and/or easement to certain land for the construction and maintenance of a comprehensive drainage project, in the Sherwood Forest area, in and without the corporate limits of the City of Mesquite, and more particularly described in Exhibit "A" attached hereto, the owners or those claiming an interest to said land being:


