RESOLUTION NO. 27-79

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, EXPRESSING SUPPORT FOR ALTERNATIVE FIVE PROPOSED BY COMMISSIONER NANCY JUDY CONSISTING OF A 59.5 MILLION DOLLAR COUNTY BOND PROGRAM AND EXPRESSING APPRECIATION TO COMMISSIONER JUDY FOR HER SUPPORT AND ASSISTANCE TO THE CITY OF MESQUITE IN ITS ROAD CONSTRUCTION GOALS; AND PROVIDING AN EFFECTIVE DATE THEREOF.

WHEREAS, the amount of the County of Dallas Bond Election approved by the voters of Dallas County in 1977 is inadequate to fund all projects approved in such election; and,

WHEREAS, various alternatives have been proposed to alleviate this problem; and

WHEREAS, Commissioner Nancy Judy of District Two is supporting an alternative consisting of a 59.5 million dollar supplemental bond election which will provide for completion of most County and State road and highway projects proposed as well as certain additions to courtroom facilities, called Alternative Number Five; and

WHEREAS, it is believed that Alternative Number Five is a common-sense approach to this problem directed primarily toward achieving the County's goals in road construction while providing only those building facilities absolutely necessary to the County's current needs with provision for future expansion; and

WHEREAS, it is believed that Alternative Number Five will provide the greatest benefit at the least cost to the taxpayer; and

WHEREAS, the City Council of the City of Mesquite is primarily concerned with the interests of the City of Mesquite, but also mindful of the duties and obligations of those within the City as citizens of Dallas County; and

WHEREAS, Commissioner Judy, since taking office as Commissioner of District Number Two has worked closely with the City of Mesquite toward the betterment of the City and its citizens; and

WHEREAS, Commissioner Judy is to be commended for her efforts in behalf of the citizens of Mesquite and her district and Dallas County as a whole.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL, OF THE CITY OF MESQUITE, TEXAS:


SECTION 1. That the City Council of the City of Mesquite does hereby support and endorse Alternative Number Five as the official County of Dallas Bond Program and urges the Honorable Gary Weber, County Judge, and the Honorable Jim Tyson, Roy Orr, and Jim Jackson, County Commissioners to join Commissioner Nancy Judy in adopting Alternative Five as the official County Bond Program for 1979 and to submit same to the voters and further urges the citizens of the City of Mesquite and of Dallas County to give their support to said Bond Program.

SECTION 2. That the City Council of the City of Mesquite does hereby express its appreciation to Commissioner Nancy Judy of District Two for the support and assistance given to the City of Mesquite in achieving its goals and providing for the needs of the citizens of the City.

SECTION 3. That a copy of this resolution be transmitted to the Honorable members of the Dallas County Commissioners Court.


SECTION 4. That this resolution take effect immediately upon passage as the law in such cases provides.
