A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, PAYING TRIBUTE TO THE REVEREND DWIGHT H. JUDY FOR HIS EFFORTS AND ACCOMPLISHMENTS FOR THE BETTERMENT OF HIS COMMUNITY AND HIS FELLOW MAN AND WISHING HIM WELL IN HIS FUTURE ENDEAVORS; AND PROVIDING AN EFFECTIVE DATE THEREOF.

WHEREAS, the Reverend Dwight H. Judy has lived and worked among us; and

WHEREAS, Reverend Judy will be sorely missed as he leaves to enter upon other endeavors; and

WHEREAS, the City Council of the City of Mesquite deems it fitting and appropriate to take time out to pay tribute to one who has been devoted and dedicated to working with and for his community and his fellow man; and

WHEREAS, lest in the midst of day to day activities we forget the contributions of Reverend Judy we take this opportunity to list some of them with the understanding that such partial listing cannot fully denote the manner of man or the extent of his service to his community:

1. Reverend Judy served as pastor of the St. Stephen United Methodist Church from 1970 to 1979;
2. Served as member of the Board of Directors and as President of the Mesquite Social Services;
3. Organized and founded the Mesquite Coordinating Council;
4. Founding Board member of Texas Impact, an ecumenical lobby for human priority issues in the Texas Legislature;
5. Founding Board member of Dallas Community College ministry;
6. Sponsor of fund-raising activity to establish the Palmer Drug Abuse Program in Mesquite;
7. Sponsor of activities to raise funds for emergency aid to families in Mesquite;

8. Contributing editor to Alive Now, Criminal Justice and the Church, a working paper for the Texas Conference of Churches in cooperation with the Texas Committee for the Humanities; and

WHEREAS, Reverend Judy gave unsparingly of himself to serve his fellow man and his community;


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:


