A RESOLUTION OF THE CITY COUNCIL OF THE CITY A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, DESIGNATING CERTAIN CITY OFFICIALS AS BEING RESPONSIBLE FOR ACTING FOR AND ON BEHALF OF THE CITY OF MESQUITE IN DEALING WITH THE TEXAS PARKS AND WILDLIFE DEPARTMENT FOR THE PURPOSE OF PARTICIPATING IN THE LAND AND WATER CONSERVATION FUND ACT IN THE LAND AND WATER CONSERVATION FUND ACT OF 1965, CERTIFYING THAT THE CITY OF MESQUITE IS ELIGIBLE TO RECEIVE ASSISTANCE UNDER SUCH PROGRAM AND PROVIDING AN EFFECTIVE DATE THEREOP.

WHEREAS, the United States Congress has passed the Land and Water Conservation Fund Act of 1965 (Public Law 88-578), authorizing the Secretary of the Interior to provide financial assistance to states, and political subdivisions thereof, for outdoor recreation purposes; and

WHEREAS, the Texas Legislature has adopted Article 6081r, V.A.C.S., for the purpose of allowing the State of Texas, and its political subdivisions, to participate in the Pederal program estab-lished under said Public Law 88-578, or such other programs as are hereinafter established by the Federal Government; and

WHEREAS, the City of Mesquite is fully eligible to receive assistance under this Program; and


