A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, AUTHORIZING THE FILING OF AN APPLICATION IN THE AMOUNT NOT EXCEPDING \$640,625.00 FOR FEDERAL FUNDS UNDER THE HOUSING AND COMMUNITY DEVELOPMENT ACT AND DESIGNATING C. K. DUGGINS AS CHIEF EXECUTIVE OPPICER AND AUTHORIZED REPRESENTATIVE FOR THE PURPOSE OF GIVING REQUIRED ASSURANCES AND ACTING IN CONNECTION WITH SAID APPLICATION, AND DECLARING THE EFFECTIVE DATE THEREOF.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the 1985-86 Final Statement of Community Development Objectives and Projected Use of CDBG Funds is hereby approved and adopted by the City of Mesquite as its official 1985-86 Community Development Block Grant Program.

SECTION 2. That C. K. Duggins, City Manager of the City of Mesquite, be and is hereby authorized to file an application for funds under the Housing and Community Development Act on behalf of the City of Mesquite, Texas, and to certify to all understandings and assurances required under said Act including, but not limited to. OMB Circulars A-92 and A-102 and Federal Management Circular 74-4; National Environmental Policy Act of 1969, Titles VI and VII of the Civil Rights Acts of 1964 and 1968 respectively, Executive Orders 11063 and 11246 and such other assurances and understandings as may be required.

SECTION 3. That this resolution shall take effect immediately upon passage as the Charter in such cases provides.
