A RESOLUTION OF THE CITY COUNCIL OF MESQUITE, TEXAS APPROVING THE STATE'S PROPOSAL TO OFFER STATE RIGHT-OF-WAY AT GALLOWAY AVENUE AND I.H. 635 FOR SALE; PROVIDING FOR RESERVATION OF AN EASEMENT TO ACCOMMODATE THE EXISTING FOUR (4) INCH GAS LINE ON THE TRACT AND DECLARING AN EFFECTIVE DATE THEREOF.

WHEREAS, the State has determined that a portion of their rightof-way at Galloway Avenue and I.H. 635 is surplus and proposes to offer the tract for sale; and

WHEREAS, the City of Mesquite has determined the right-of-way in question will not be needed for current or future needs; and

WHEREAS, there is an existing four (4) inch gas line present in the right-of-way which necessitates the reservation of an easement in the event the right-of-way is sold;
