A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, AUTHORIZING MAYOR GEORGE A. VENNER, SR. TO ENTER INTO AN AGREEMENT FOR THE CONSTRUCTION OF PAVING AND DRAINAGE IMPROVEMENTS WITH THE BRUTON ROAD PROJECT IN DISTRICT 2 AND DECLARING AN EFFECTIVE DATE THEREOF.

WHEREAS, the City of Mesquite, Texas hereinafter called "City", and the County of Dallas, Texas, hereinafter called "County", want to enter into an agreement for the construction of paving and drainage improvements in connection with the Bruton Road Project 490-413 from IH-635 to Pioneer Road in DISTRICT 2 and the County of Dallas, Texas; and

WHEREAS, pursuant to Proposition II of the 1985 Dallas County Thoroughfare Bond Program the County has funding to design, acquire one hundred feet (100°) of Right-of-Way, and construct a 4-lane divided urban thoroughfare with drainage improvements capable of being widened to a 6-lane divided urban thoroughfare in the future from Interstate Highway 635 (IH 635) to Pioneer Road; and

WHEREAS, the City has requested that the scope of the project be increased to design and construct a 6-lane divided urban thoroughfare, from IH-635 to Pioneer Road, hereinafter called "Work"; and

WHEREAS, the Interlocal Cooperation Act, Article 4413 (32c) Vernon's Annotated Civil Statutes provides authorization from any local government to contract with one or more local governments to perform governmental functions and services under the terms of the ACT; and

WHEREAS, it is in the interest of the City of Mesquite, to enter into such agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That Mayor George A. Venner, Sr. is hereby authorized to enter into an agreement for the construction of paving and drainage improvements in connection with the Bruton Road Project 490-413 from IH-635 to Pioneer Road in DISTRICT 2 and the County of Dallas, Texas.

SECTION 2. That this resolution take effect immediately from and after its passage as the law in such cases provides.
