- A. The City of Mesquite shall pay damages or losses that Ben Franklin is legally obligated to pay arising out of the above-styled lawsuit.
- B. In addition to the coverage provided in paragraph A, the City will pay:
 - 1. The City's expenses in investigating and defending the claim or lawsuit;
 - Costs taxed against Ben Franklin in the suit covered by this resolution and interest that accrues after entry of judgment before the City has deposited payment with the court on that part of the judgment which does not exceed the limits of coverage:
 - 3. Reasonable expenses of the employee incurred at the City's request; and
 - 4. Attorney's fees ordered by the court to be paid by the employee.
