RESOLUTION NO. 11-89

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, REQUESTING THAT THE STATE DEPARTMENT OF HIGHWAYS AND PUBLIC TRANSPORTATION RECONSTRUCT THE THREE (3) BRIDGES ON LAWSON ROAD SCHEDULED FOR REPLACEMENT UNDER THE FEDERAL AID BRIDGE REPLACEMENT PROGRAM, COMMITTING THE CITY OF MESQUITE TO FUND THE SHORTFALL AND ACQUIRE NEEDED RIGHT-OF-WAY AND EASEMENTS; DESIGNATING JAMES A. PRUGEL AS AUTHORIZED REPRESENTATIVE FOR THE PURPOSE OF GIVING REQUIRED ASSURANCES, AND DECLARING AN EFFECTIVE DATE THEREOF.

WHEREAS, a need exists for the reconstruction and enlargement of three (3) bridges on Lawson Road in Mesquite, Dallas County, Texas; and

WHEREAS, Dallas County had requested the State Department of Highways and Public Transportation reconstruct said bridges when the bridges were under the County's jurisdiction, prior to the City of Mesquite annexing the area in which the bridges are located; and

WHEREAS, funds are available for such reconstruction from the State Department of Highways and Public Transportation, with possible contribution from Dallas County, and the City of Mesquite has agreed to fund the shortfall between the actual costs and the funding provided by the State Department of Highways and Public Transportation and Dallas County, and acquire the needed right of way and easements;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the City of Mesquite request the State Department of Highways and Public Transportation reconstruct the three (3) bridges on Lawson Road in Mesquite, Dallas County, Texas which are scheduled for replacement under the "Federal Aid Bridge Replacement Program", and that such reconstruction be in conformance with the report "Lawson Road Bridge Evaluations" by Nathan Maier Consulting Engineers, Inc.


SECTION 2. That the City of Mesquite commits to funding the shortfall between the actual costs of reconstruction and the funding provided by the State Department of Highways and Public Transportation and Dallas County, and acquiring the needed right-of-way and easements. The cost of shortfall estimated to be approximately \$470,700.00.

SECTION 3. That James A. Prugel, City Manager, be and is hereby designated as the authorized Representative to act in behalf of the City of Mesquite to certify to all understandings and assurances required by the State Department of Highways and Public Transportation and Dallas County.


SECTION 4. That this Resolution shall take effect immediately upon passage as the Charter in such cases provides.


