A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, PROVIDING THAT THE CITY WILL SAVE, PROTECT, DEFEND, HOLD HARMLESS, GIVE A PER DIEM, PAY EXPENSES AND INDEMNIFY EX-ELECTED AND APPOINTED OFFICIALS AND EX-EMPLOYEES FROM CLAIMS, SUIT OR JUDGMENT IN CONNECTION WITH LAWSUITS FILED AGAINST THE CITY OF MESQUITE AND SAID EX-ELECTED AND APPOINTED OFFICIALS, AND EX-EMPLOYEES; AND PROVIDING AN EFFECTIVE DATE THEREOF.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the City of Mesquite shall at City expense save, protect, defend, hold harmless, give a per diem, pay expenses and indemnify ex-elected and appointed officials and ex-employees from claims, suit or judgment in connection with lawsuits filed against the City of Mesquite and said ex-elected and appointed officials, and ex-employees resulting from acts performed within the course of employment or within the scope of the official duties of office.

- A. The City of Mesquite shall pay damages or losses that said ex-elected and appointed officials, and ex-employees are legally obligated to pay arising from a lawsuit.
- B. In addition to the coverage provided in paragraph A, the City will pay:
 - 1. The City's expenses in investigating and defending the claim or lawsuit;
 - Costs taxed against said ex-elected and appointed officials, and ex-employees in a suit covered by this resolution and interest that accrues after entry of judgment before the City has deposited payment with the court.
 - The per diem will be \$75.00 per day for said ex-elected and appointed officials and exdepartment heads, and \$50.00 per day for all other ex-employees; and
 - Expenses incurred at the City's request for said ex-elected and appointed officials, and ex-employees including mileage.
 - Attorney's fees ordered by the court to be paid by the ex-elected and appointed officials and ex-employees.
- C. To be entitled to coverage, the said ex-elected and appointed officials, and ex-employees must:
 - Cooperate with the City Attorney and/or outside counsel selected by the City, and
 upon their request, assist in conducting the lawsuits;
 - Attend hearings and trials and assist in securing and giving evidence and obtaining the attendance of witnesses;
 - 3. Not, except upon advice of the City Attorney or outside counsel, give any oral or written statement or enter into any stipulation or agreement concerning a claim or levelit; and
 - Not, except at the said ex-elected and appointed officials, or ex-employee's own cost, voluntarily make any payment, assume any obligation, or incur any expense with respect to a claim or lawsuit without the consent of the City.
