RESOLUTION NO. 2-90

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, AUTHORIZING THE MAYOR TO EXECUTE THREE (3) SANITARY SEWER PIPELINE AGREEMENTS AND PAYMENT OF THREE (3) \$1,500.00 LICENSE FEES (\$4,500.00 TOTAL) TO MISSOURI PACIFIC RAILROAD COMPANY, FOR THE SOUTH MESQUITE CREEK SANITARY SEWER TRUNK MAIN REALIGNMENT PROJECT; AND DECLARING AN EFFECTIVE DATE THEREOF.

WHEREAS, Missouri Pacific Railroad Company (hereinafter called Railroad Company) has tendered to the City of Mesquite, State of Texas, (hereinafter called City) three (3) licenses for sanitary sewer pipeline crossings at Mile Posts 203+42, E.C.S. 10771+27, 10771+20, 1077+13, Mesquite, Texas; and

WHEREAS, the Council of said City has said proposed agreements before it and has given them careful review and consideration; and

WHEREAS, it is considered that the best interests of said City will be subserved by the acceptance of said agreements;


NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the terms of the agreements submitted by the Railroad Company as aforesaid be, and the same are hereby, accepted in behalf of said City, including the payment of \$4,500.00 for license fees.


SECTION 2. That the Mayor of said City is hereby authorized, empowered, and directed to execute said agreements on behalf of said City and that the City Secretary of said City is hereby authorized and directed to attest said agreements and to attached to each duplicate original of said agreements a certified copy of this resolution.

SECTION 3. That this resolution shall take effect immediately upon date of passage as the law in such cases provides.
