

RESOLUTION NO. 10-91

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF AN ELECTION HELD IN THE CITY OF MESQUITE, TEXAS ON MAY 4, 1991, FOR THE ELECTION OF A MAYOR AND CITY COUNCILMEMBERS FOR PLACES 1, 2, AND 6, AND FOR DETERMINING THE ISSUE OF COLLECTIVE BARGAINING FOR FIRE AND POLICE EMPLOYEES; AND DECLARING AN EFFECTIVE DATE THEREOF.

WHEREAS, a City Election was held on May 4, 1991, for the purpose of electing a Mayor and Councilmembers for each of the following places: Nos. 1, 2, and 6; for two (2) year terms; and for the purpose of determining the issue of collective bargaining for fire and police employees; and

WHEREAS, immediately after said election the Presiding Judges and other officers holding said election made their returns of the results thereof to the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That after examining said returns of said election and canvassing the votes in said election, the results of the election held May 4, 1991, are declared to be as follows:

It appearing that Cathy Ray received a majority of votes cast for the Office of Mayor, she is hereby declared to be elected to said office to serve after qualifying for a term of two (2) years, commencing May, 1991, and until a successor shall have been elected and shall have qualified.

It appearing that no candidate received a majority of votes cast for the Office of Councilmember, Place 1, it is necessary to call a run-off election to be held May 18, 1991, for the purpose of deciding between Bill Cox and John Heiman for the Office of Councilmember, Place 1.

It appearing that Bill Newman received a majority of votes cast for the Office of Councilmember, Place 2, he is hereby declared to be elected to said office to serve, after qualifying, for a term of two (2) years, commencing May, 1991, and until a successor shall have been elected and shall have qualified.

It appearing that Carole Lochhead received a majority of votes cast for the Office of Councilmember, Place 6, she is hereby declared to be elected to said office to serve, after qualifying, for a term of two (2) years, commencing May, 1991, and until a successor shall have been elected and shall have qualified.


It appearing that a majority of the votes were cast against the issue of collective bargaining for fire and police employees, the proposition is hereby determined to have failed.

SECTION 2. Absentee voting for the May 18, 1991, Runoff Election shall be conducted in the office of the City Secretary, Municipal Center, 1515 N. Galloway, Mesquite, Texas beginning on May 9, 1991, and continuing each day thereof through May 14, 1991, from 8:00 a.m. until 5:00 p.m., excepting Saturdays, Sundays, and holidays. Additional absentee voting shall be conducted in the office of the City Secretary on Saturday, May 11, 1991, from 10:00 a.m. until 3:00 p.m.



SECTION 3. That this Resolution shall become effective immediately upon passage, as the Charter in such cases provides.


