RESOLUTION NO. 18-91

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, APPOINTING JUDGES AND ALTERNATE JUDGES FOR THE AUGUST 10, 1991, SPECIAL ELECTION AND PROVIDING THE EFFECTIVE DATE THEREOF.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:




Lynn Prugel, Counting Station Manager;

Willie Donehoo, Presiding Judge.


**SECTION 4.** That this resolution take effect immediately from and after its passage as the law in such cases provides.
