RESOLUTION NO. 17-93

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, DESIGNATING AN OFFICIAL NEWSPAPER SUBJECT TO CERTAIN CONDITIONS, FOR THE CITY OF MESQUITE FOR PUBLICATION OF THE CITY'S LEGAL ADVERTISEMENTS FOR A ONE-YEAR PERIOD; AND DECLARING AN EFFECTIVE DATE THEREOF.

WHEREAS, the agreement for publication of legal advertisements for the City of Mesquite will expire on September, 30, 1993; and

WHEREAS, the City Council has considered the proposal of public newspapers of general circulation in the City for designation as the official paper;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the Coppell Gazette, dba Mesquite News, a public newspaper of general circulation in the City of Mesquite, Texas, is hereby designated as the official paper of the City of Mesquite for the year beginning October 1, 1993, and ending September 30, 1994, subject to the following conditions:

- (a) Receipt of a letter from the attorney for Harte-Hanks Community Newspaper stating that the Mesquite News combined with the Coppell Gazette will fulfill all requirements of Articles 28a and 29a of Vernon's Civil Statutes; or
- (b) A "hold harmless" agreement to the City from Harte-Hanks that all financial loss suffered by the City of Mesquite due to the fact that the Mesquite News does not have a second-class postal permit, will be paid by Harte-Hanks; and
- (c) Proof that the Coppell Gazette is published in Dallas County.

Further, if the proper documentation cannot be provided to the City Attorney within thirty (30) days, the <u>Dallas Morning News</u> will be designated as the official newspaper for the City of Mesquite for the one-year period beginning October 1, 1993 and ending September 30, 1994.

SECTION 2. That all ordinances, notices, and other matters required to be published under the laws of the State of Texas, the Charter of the City of Mesquite, or any ordinance thereof, shall be published in such official newspaper.

SECTION 3. That such paper shall continue to act as the official newspaper of the City until another is designated by the City Council.

SECTION 4. That this resolution shall take effect immediately upon date of passage, as the law in such cases provides.
