The City of Mesquite does hereby give notice of intention to issue Combination Tax and Revenue Certificates of Obligation, Taxable Series 1995, in the maximum principal amount not to exceed \$7,075,000 for paying all or a portion of the City's contractual obligations for the purpose of constructing and equipping a Municipal Convention Center and acquiring land in connection therefor, and for paying legal, fiscal, architectural, engineering and professional fees in connection with such projects. The City proposes to provide for the payment of such Certificates of Obligation from the levy and collection of ad valorem taxes in the City as provided by law, and from a limited pledge of the surplus revenues of the City's Convention Center, remaining after payment of all operation and maintenance expenses thereof, and all debt service, reserve, and other requirements in connection with any of the City's revenue bonds or other obligations (now or hereafter outstanding), which are payable from all or any part of the Net Revenues of the City's Convention Center. The City Council intends to consider for passage, at a Special Meeting to be held at 11:30 A.M. on November 13, 1995, an Ordinance authorizing the issuance of Combination Tax and Convention Center Revenue Certificates of Obligation, Taxable Series 1995, in the Administration Conference Room of the Municipal Center, 1515 N. Galloway, Mesquite, Texas.
