A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, ADOPTING RULES TO IMPLEMENT CHAPTER 574 OF THE TEXAS GOVERNMENT CODE, AND MAKING A RECORD OF CERTAIN FINDINGS REQUIRED BY SUCH CHAPTER 574; AND ARTICLE 16 §40 OF THE TEXAS CONSTITUTION AND DECLARING AN EFFECTIVE DATE THEREOF.

WHEREAS, the City of Mesquite pursuant to Chapter 574 of the Texas Government Code, desires to adopt rules to implement the provisions of said Chapter dealing with statutory and Constitutional requirements for certain non-elective officers serving in dual capacities and/or offices; and

WHEREAS, the City of Mesquite finds that service by Judge Robert J. Beasley, Municipal Court Judge for the City of Garland, as an Associate Judge for the City of Mesquite Municipal Court is a benefit to the City of Mesquite and the State of Texas; and

WHEREAS, the City of Mesquite further finds that such service by Judge Robert J. Beasley as an Associate Judge of the Mesquite Municipal Court is not in conflict with Judge Beasley's position with the City of Garland; and

WHEREAS, the City of Mesquite has previously adopted a schedule of compensation for particular duties performed by Associate Judges in and for the City of Mesquite, and that Judge Beasley's compensation shall be governed thereby, unless or until such schedule shall be revised or amended hereafter;


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

<u>SECTION 1.</u> That the City Council of the City of Mesquite pursuant to Chapter 574 of the Texas Government Code, and Article 16 §40 of the Texas Constitution hereby adopts and enacts the provision of such Chapter.

<u>SECTION 2</u>. That Judge Robert J. Beasley's service as an Associate Municipal Court Judge for the City of Mesquite is a benefit to the City of Mesquite, and the State of Texas.

<u>SECTION 3</u>. That service by Judge Robert J. Beasley as an Associate Municipal Court Judge for Mesquite is not in conflict with his service as Judge of the City of Garland Municipal Court.

<u>SECTION 4</u>. That compensation due Judge Robert J. Beasley as an Associate Municipal Court Judge shall continue to be determined under the previously adopted schedule of compensation, unless or until such schedule shall be revised or amended.
