#### Abstract

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, CALLING A PUBLIC HEARING ON THE CREATION OF REINVESTMENT ZONE NO. ELEVEN FOR COMMERCIAL/INDUSTRIAL TAX ABATEMENT FOR DUKE ENERGY NORTH AMERICA, AND AUTHORIZING NOTICE OF SUCH HEARING.


WHEREAS, the City Council of the City of Mesquite, Texas (the City), desires to promote the development or redevelopment of certain contiguous areas within its jurisdiction by the creation of reinvestment zone; and

WHEREAS, the City has preliminarily determined that the area described by the metes and bounds description (attached hereto as Exhibit "A" and made a part hereof) meets the criteria for a reinvestment zone under the Property Redevelopment and Tax Abatement Act, Chapter 312, V.T.C.A., Tax Code, as amended (the Code); and

WHEREAS, the Code further requires that prior to the adoption of the ordinance providing for establishment of a reinvestment zone to promote development or redevelopment within such zone through the use of tax abatement as authorized by the Code, the City must hold a public hearing on the adoption of the proposed reinvestment zone and find that the improvements sought are feasible and practical and would be of benefit to the land to be included in the zone and to the municipality, providing interested persons the opportunity to speak and present evidence for or against the designation; and

WHEREAS, the City desires by calling and holding such public hearings to provide a reasonable opportunity for an owner of property located within the proposed zone and all other taxing entities and other interested persons to address the creation of the proposed reinvestment zone or the inclusion of any property therein.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That public hearing shall be held at 3:00 p.m. on September 20, 1999, in the City Council Chamber, City Hall, Mesquite, Dallas County, Texas, at which time any interested person may appear and speak for or against the benefits to the City, its residents and property owners in the proposed Reinvestment Zone No. Eleven, for Duke Energy North America, whether all or part of the territory described in the metes and bounds description attached hereto as Exhibit "A" should be included in such proposed reinvestment zone, and the concept of tax abatement.

SECTION 2. That notice of such public hearings shall be published in the official newspaper of the City of Mesquite not later than seven (7) days prior to the date of such hearings, and that written notice of such hearings along with a copy of the resolution shall be sent by mail to all taxing units overlapping the territory inside the proposed reinvestment zones.
