

RESOLUTION NO. 52-2000
 EXPRESSING OFFICIAL INTENT TO REIMBURSE COSTS
 FOR MUNICIPAL IMPROVEMENTS
 FROM COMBINATION TAX AND REVENUE
 CERTIFICATES OF OBLIGATION
 SERIES 2000

THE STATE OF TEXAS :

WHEREAS, the City of Mesquite, Texas (the "Issuer") is a political subdivision of the State of Texas; and

WHEREAS, the Issuer expects to pay capital expenditures in connection with constructing and equipping a new airport terminal at the City of Mesquite Metro Airport, acquiring and installing emergency warnings sirens, installing roof replacements at the City Hall, fire station improvements (fence and restrooms), roof improvements for fire station, municipal courts, and main library, partial re-paving of City Hall parking lot, acquiring and installing municipal center chiller replacement and records management program ("Project") prior to the issuance of Certificates of Obligations to finance the Project; and

WHEREAS, the Issuer finds, considers, and declares that the reimbursement of the Issuer for the payment of such expenditures will be appropriate and consistent with the lawful objectives of the Issuer and, as such, chooses to declare its intention, in accordance with the provisions of Section 1.150-2 of the Treasury Regulations, to reimburse itself for such payments at such time as it issues obligations to finance the Project.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS THAT:


Section 1. The Issuer reasonably expects to incur debt, as one or more series of obligations, with an aggregate maximum principal amount equal to \$870,000 for the purpose of paying costs of the Project.

Section 2. All costs to be reimbursed pursuant hereto will be capital expenditures. No tax-exempt obligations will be issued by the Issuer in furtherance of this Resolution after a date which is later than 18 months after the later of (1) the date the expenditures are paid or (2) the date on which the property, with respect to which such expenditures were made, is placed in service.

Section 3. The foregoing notwithstanding, no tax-exempt obligation will be issued pursuant to this Resolution more than three years after the date any expenditure which is to be reimbursed is paid.



NOES: None.


