## RESOLUTION NO. 61-2002

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, DESIGNATING A DEVELOPMENT AREA ON APPROXIMATELY 26.246 ACRES LOCATED AT 1410 WOODED LAKE DRIVE FOR THE PURPOSE OF DEVELOPMENT AND OPERATION OF YOUTH BASEBALL FIELDS.

WHEREAS, in accordance with the Texas Development Corporation Act of 1979, Article 5190.6, Vernon's Texas Civil Statutes, as amended (the "Act"), and Chapter 180.2 of the Texas Administrative Code, the City Council of the City of Mesquite, Texas, hereby designates the land containing approximately 26.246 acres located at 1410 Wooded Lake Drive, Mesquite, Texas, and owned by Texas Amateur Baseball Congress, Inc., d/b/a Boys Baseball, Inc., as a development area (the "Development Area") under the Act; and

WHEREAS, the Development Area shall be developed in order to meet the development objectives of the City, which overall objectives for the Development Area include the development and operation of youth baseball fields and related buildings, parking, open space and improvements; and

WHEREAS, the City Council finds that the availability of financing of projects for commercial uses under the Act will contribute significantly to the development of the Development Area; and

WHEREAS, in order to enhance the development efforts of the Development Area, the City Council desires that land, buildings, facilities and improvements required or suitable for use for professional and amateur (including children's) sports, athletic, entertainment and public park purposes and events including ballparks, park facilities, open space improvements and related concessions, parking facilities, roads, streets and other related improvements that enhance any of those items be developed in the Development Area; and

WHEREAS, the City Council will review all project descriptions for approval of specific projects for commercial uses in order to determine whether such projects are consistent with the City's objectives for development of the Development Area; and

WHEREAS, based upon the City's best estimates at the time of the adoption of this resolution, three youth baseball fields, office and concession building, parking and other related improvements that exist in the Development Area shall be financed or refinanced through tax exempt bonds issued through the Mesquite Industrial Development Corporation.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE:

SECTION 1. That in accordance with the Texas Development Corporation Act of 1979, Article 5190.6, Vernon's Texas Civil Statutes, as amended (the "Act"), and Chapter 180.2 of the Texas Administrative Code, the City Council of the City of Mesquite, Texas, hereby

THENCE, South 62 degrees, 50 minutes, 01 seconds East, continuing along said southerly line, a distance of 1172.74 feet to a 1/2—inch iron rod with "Pacheco Koch" cap found for corner;

THENCE, South 44 degrees, 52 minutes, 00 seconds West, a distance of 1.633.47 feet to a 1/2—Inch iron rod with "Pacheco Koch" cap set for corner;

THENCE, North 74 degrees, 03 minutes, 19 seconds West, a distance of 326.84 feet to a 1/2—Inch Iron rod with "Pacheco Koch" cap set in the northeasterly line of said Wooded Lake Drive (60—foot right—of—way at this point); said point being on a non—tangent curve to the right whose center bears South 74 degrees, 03 minutes, 19 seconds East, a distance of 1,836.00 feet from said point;

THENCE, along sold northeasterly line and sold curve to the right, through a central angle of 15 degrees, 58 minutes, 04 seconds, on arc length of 511.67 feet to a 1/2—inch iron rod with "Pacheco Koch" cap found at the end of sold curve;
